Agreement to Terms

By endorsing this Agreement to become an affiliate of LiveUp Resources (“we,” “our,” or “us”), you (“Affiliate”) agree to abide by the following Terms and Conditions. Your participation in the Affiliate Program is subject to these terms, and we reserve the right to update or modify these terms at any time. 1. Program Participation

- Affiliates may start and end their participation in the program at any time by providing written notice to us via email at pcsmedia@pacounseling.com.
- To participate, Affiliates must sign up through our website and be approved by us.

2. Affiliate Responsibilities

5. Termination of Participation

- We reserve the right to terminate an affiliate's participation if they violate these terms or engage in activities that harm our reputation and will do so in writing.

- Affiliates must not modify, distribute, or misuse any intellectual property provided by us.
